Required Documents

- Covering letter request for purpose of visit -Original letter with travel plan. If the applicant is submitting the applications of his/her family, then all applications must include a copy of the covering letter
- Valid passport with at least 6 months validity from the date of arrival
- Two recent photographs (3.5 x 4.5 cm, white background, 80% face coverage)
- Confirmed return flight tickets and hotel bookings
- Bank statements for the last 3 months with a minimum balance of ₹50,000

Other Documents

- No Objection Certificate (NOC) from employer (if employed)
- Business registration proof (if self-employed)
- School ID card or NOC (for students)

Optional Documents

- Sponsorship letter if someone else is funding the trip
- Property documents or other asset proofs

Application Process

1. We match your passport and port of entry to the correct online form or embassy appointment.

- 2. Funds, hotel bookings, and return/onward tickets are checked against Thai immigration expectations.
- 3. You submit payment for official fees only after we agree the file is coherent.
- 4. If an e-visa is issued, we help you understand validity dates before you book non-refundable flights.
- 5. Final entry is always decided by Thai immigration officers at the border.
